## UNFINISHED BUSINESS

### Dental Coverage

The Commissioners reviewed the details of the WFOA dental coverage and the rate plans. There was a discussion on whether or not it would be beneficial to have orthodontia coverage and after some discussion it was decided that it would not be necessary at this time.

*Motion:* Commissioner Pollman made a motion that the department pays 100% of the employee dental insurance premium effective January 2008. Chairman Rogers seconded the motion. Motion carried and approved.

## NEW BUSINESS

### Employee Medical Insurance

Secretary Kelly informed the Board that the employee medical insurance premium increased for 2008. Secretary Kelly asked the department to increase the premium for Chief Jaques to \$525.00 per month and Secretary Kelly to \$498.00 in order to cover the increase.

*Motion:* Commissioner Pollman made a motion that the department increases the medical insurance premiums to the amount of \$525.00 per month for the Chief and \$498.00 a month for the Secretary. Chairman Rogers seconded the motion. Motion carried and approved.

## COMMISSIONER'S COMMENTS

There was a discussion on possibly relocating the department due to the flood risks or possibly raising the building at the current location. Chief Jaques suggested the old mill site next to Arrow Lumber as a possible location that would be out of the flood plain.

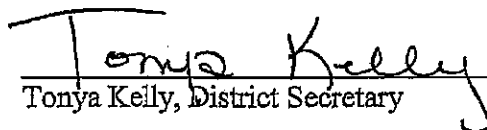
