UNFINISHED BUSINESS

Operation Guidelines

- Distributed CD to Commissioner John Pollman and Commissioner Dale Woody and hard copy notebook to Chairman Red Rogers
- Volunteer will receive their own copy of Guidelines on CD
- 2 hard copies in notebooks are available in the Day Room
- Commissioner John Pollman suggested having a sign-off sheet for volunteers as they receive their Guidelines on CD - to protect the district
 - o Fire Chief Jeff Jaques mentioned that HIPPA and sexual harassment are personally signed and kept in folder

Commissioners and Fire Chief Jeff Jaques agreed to remove operation guidelines from agenda since the huge bulk of the Guidelines are completed. Will be adding or editing Guidelines as needed.

Tacoma Power – New 5 year agreement – Fire Chief Jeff Jaques

- Fire Chief Jeff Jaques left message with David Letterman; he has not heard back
- Current Contract states 2011 2015 Will need back payment for 2012

Hopefully will have contract ready for next months meeting

EMS Levy – possibly Fall 2013

- Agreement of General election in the Fall Resolution needs to be signed by August 6, 2013
- Community support is important Commissioner Red Rogers
- Fire budget is supporting the EMS budget EMS Levy would help tremendously with preparing for future equipment and apparatus

Salary – Fire Chief Jeff Jaques & District Secretary Penny Owens

- Chairman Red Rogers concerned with economic conditions of the Fire District
- Cost of Living -2-3 % per Commissioner Dale Woody
- Last raise for District Secretary Penny Owens 2 years Nov. 2010
- Last raise for Fire Chief Jeff Jaques 3 years Dec. 2009
- Commissioner Dale Woody suggested 4% salary raise for Penny and 6% salary raise for Jeff - retroactive from January 2013
- Commissioner Dale Woody suggested offering Penny vacation pay; 24 hours grandfathered in for now and first of February another 24 hours. Vacation for Penny 24 hours annually on February 1 of each year

On a motion made by Commissioner John Pollman and seconded by Commissioner Dale Woody:

"Fire Chief Jeff Jaques will receive a 6% salary raise from \$4,607./monthly to \$4,883./monthly, District Secretary Penny Owens will receive a 4% salary raise from \$1,756./monthly to \$1,826./monthly, retroactive from January 2013. District Secretary Penny Owens will receive vacation time of 24 hours/annually starting on February 1 each year. She will be grandfathered in with 24 hours as of today."

MOTION CARRIED UNANIMOUSLY

NEW BUSINESS

Off Budget Debt – Commissioner Dale Woody

- Fire Chief Jeff Jaques' vacation time approx. 350 hours with no cap according to his contract
- This is a debt of \$10,000 to the Fire District what needs to be included in the budget and set aside incase Jeff retires, is injured, leaves the district, or other situation
- Discussion
 - o Place a cap on number of vacation hours
 - o Possibly buy out extended hours to keep vacation hours at a cap or limit
 - o will need to adjust/amend Fire Chief Jeff Jaques' contract if cap or limit decided
 - o Additional discussion at March's Board Meeting

Physical Inventory – Commissioner Dale Woody

- Need to know where and when items come in
- Fire Chief Jeff Jaques Access tags on product as it comes in and current value documented

- Fire Chief Jeff Jaques Physical Inventory requirements are in the polices already
- Fire Chief Jeff Jaques is tracking equipment and apparatus on ER program
- Commissioner Dale Woody is concerned of items and inventory of over \$500
- Fire Chief Jeff Jaques said he would be confident if he was questioned on inventory, location, and value

COMMISSIONER'S COMMENTS

Commissioner Dale Woody – will be leaving the Randle Fire District as Commissioner and leaving the area by the end of the year

 Dale suggested if anyone is interested in running for the position in Nov. 2013, they will need to contact the election office to register for the ballot by the first week of June
