 - Fire Chief Jeff Jaques will contact US Fire Equipment to verify and discuss a current list and cost of repairs compared with the second opinion
 - o The Commissioners agreed to wait to repair this vehicle until Fire Chief Jeff Jaques receives a final repair list from US Fire Equipment and this second opinion
 - o Possible a special meeting if Fire Chief Jeff Jaques can acquire a current list and cost of repairs
